This year's Spring Fling will be held April 25<sup>th</sup> & 26<sup>th</sup> at the Grant County Civic Center. All vendors are required to complete and return the enclosed contract with payment no later than Friday, April 18, 2025. <u>To help accommodate your needs</u>, we have included spaces on the contract for the number of tables & chairs you would like in your booth. Contracts with full payment must be received by Friday, April 4<sup>th</sup>, to be eligible for the "early bird" discount. New assignments or changes will be made after this early deadline on a first come-first served basis for booths that have not been renewed. Please indicate on the contract your 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> choice booth location. We will do our best to accommodate your choice; however, please be aware that <u>submission of this contract with payment does not guarantee a booth space or a preferred location</u>. In the event that booth space is unavailable, payment will be returned in full to the respective vendor. Please also note the following:

## <u>Please note the Kansas state sales tax information</u> <u>below and provide your sales tax # on the contract</u> <u>form:</u>

# "All federal, state, and local laws governing retail sales tax must be followed. By signing the enclosed contract I understand the rules and regulations of the show and will comply. I realize that failure to comply may result in expulsion from the show."

If you do not currently have a Sales Tax Registration Certificate, we will provide you with a packet from the Kansas Department of Revenue.

#### **Recommendations from the State of Kansas:**

**REQUIRE VENDORS to DISPLAY THEIR REGISTRATION CERTIFICATE**. If they do not have a sales tax number they may display the certificate provided in the packet provided they only show in the state no more than two times per year. The number will be the same number in each packet as it is assigned to the specific event. If used, the sales tax must be remitted immediately after the show in the envelope provided or turned into the coordinator to be sent to compliance representative at 1883 W 21<sup>st</sup> St N Wichita KS 67203.

The Kansas Department of Revenue's (KDOR) expectations of the Grant County Chamber of Commerce:

- Cooperate fully with the Compliance Field Agent who will be in contact with you.
- Furnish the agent with a list of all participating vendors 14 days prior to the event.
- Distribute the information furnished by KDOR to the participants in your event.
- Assure that all retailers participating either have a current sales tax certificate or agree to remit the tax collected immediately after the event. (A requirement of KSA 79-3608)
- Make certain that the participants are aware of the current state and local sales tax rate for the jurisdiction in which the event is scheduled.
- Support our agents if they ask a non-compliant vendor to leave the event.
- Assure that businesses selling tangible personal property at the event shall have their records from sales at the event available during business hours. (A requirement of KSA 79-3609)
